Graduate Psychology Education Fellowship

Open to UNT Clinical Psychology doctoral students

Fellowship Requirements

GPE Fellows must complete the following requirements during their Fellowship year:

- At least three 60-minute webinars on the integration of social determinants of health (SDOH) interventions in health centers
- 10 hours of culturally appropriate, trauma-informed service training
- 10 hours focused on cultural, racial, linguistic, and geographic diversity of the populations and communities served and enrichment of OUD/SUD competencies
- 5-week OUD/SUD training workshop provided at UNT by expert consultants
- Compassion Fatigue course (all fees paid)
- Areas of Worklife Survey (AWS) with feedback (all fees paid)
- Maslach Burnout Inventory (MBI) with feedback (all fees paid)
- Engagement and use of mindfulness and meditation apps (fees for usage paid)
- Monthly completion of ProQOL measure

Practicum Training Requirements

Required elements of the experiential practicum training component of the fellowship experience include:

- Signed supervisor verification form at start of placement
- Monthly summary of supervision hours in training log; the following metrics will be tracked monthly:
 - 390 (or more) face-to-face service hours
 - Greater than 10% of service hours provided through tele-health
 - Work on inter-disciplinary teams, with at least two other disciplines (e.g., psychiatry, nursing, social work).
 - MAT prescriber involved treatment team experience during fellowship year
 - Greater than 25% of clients served involve SUD/ODU services (e.g., screening, treatment)
 - Greater than 50% of clients served from an URM (Hispanic/Latinx OR African American/Black), rural, and/or economically disadvantaged populations
 - Services provided canvas the North Texas geographic areas most in need (tracked via client ZIP codes mapped to federally recognized HPSA/MUA locations)

Our Regional Partners

VA NORTH TEXAS HEALTH CARE SYSTEM

VA North Texas Health Care System (VANTHCS) offers training including primary mental health integration, general outpatient, residential treatment, and inpatient psychiatry. All are interdisciplinary (i.e., psychologists, psychiatrists, social workers, and other such as nurses and pharmacists). This site also offers opportunity to work with clients with SUD primary diagnoses. Trainees also participate in the Telemental Health/Rural Mental Health Team, which provides services to underserved rural areas throughout North Texas and Southern Oklahoma.

JOHN PETER SMITH HOSPITAL

The John Peter Smith (JPS) Hospital provides direct exposure to primary care, as trainees learn alongside fellows in residency programs in psychiatry, emergency medicine, and other medical specialties. Located in a Health Professional Shortage Area (HPSA ID: 7483111792), the hospital serves a diverse, traditionally underserved population in Tarrant County, many of whom have SUDs. P

STEVEN A. COHEN MILITARY FAMILY CLINIC AT METROCARE

he Steven A. Cohen Military Family Clinic at Metrocare is an interdisciplinary clinic staffed by psychologists, Licensed Clinical Social Workers (LCSWs), Certified Licensed Professional Counselors (LPCs), psychiatrists, Licensed Marital and Family Therapists (LMFTs), and Licensed Chemical Dependency Counselors (LCDCs). Trainees are required to complete didactic training organized through the Cohen Veterans Network including specific trainings in SUD services. The Cohen Clinic also offers opportunities in telehealth.
